## Background and scope

SARD JV Ltd ("we", "our", "us") is committed to safeguarding the privacy of visitors to our website. This Privacy Notice explains how we collect, use, and protect your personal information when you visit this website or provide information via our contact form, in compliance with the Data Protection Act 2018 and the UK General Data Protection Regulation (UK GDPR). For the avoidance of doubt, User Data held within the SARD software product systems remains in the Control of the Trust or Organisation who holds a contract with us as Processors and is not within the scope of this notice.

Personal data is any information relating to an identified or identifiable living person. It is our policy to be transparent about how and why we collect and process personal data.

#### What information do we collect?

We may collect and process the following personal data when you visit our website or use our contact form:

- Technical Data: We may collect non-identifiable technical data through cookies, including your IP address, browser type, pages visited, and other basic analytics data. Please see our on-screen Cookie Consent Preferences for more information.

#### How we use your personal information

We use your data for the following purposes:

- Enquiry and Mailing List Contact Forms: We use the information you provide in contact forms to respond to your enquiries and to follow up on any requests or communications. This information will be used only for these purposes unless you consent to further contact (e.g., newsletters).
- **Analytics:** We may collect non-identifiable data to help us understand how visitors interact with our website, allowing us to improve the user experience and identify improvements and opportunities for our service.

We will not sell or share your personal data with third parties, except where necessary to provide our services or comply with legal obligations.
